The Northwest Quarter of the Southwest Quarter of Section Eight (8); The East Half of the Southwest Quarter of Section Eight (8) in Township Eight (8) North, Range Seven (7), West of the Third Principal Meridian, Macoupin County, Illinois; (**PPN: 10-000-112-00**). Except that part deeded to Michael R. Bertolino by deed dated November 13, 2002 and filed November 20, 2002 as Document Number 414389; (W $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 8, T8N, R7W).

Also excepting that part deeded to Mark Link and Angie Link by deed dated October 7, 2004 and filed October 7, 2004 as Document Number 441163; more particularly described as follows: Part of the Southeast Quarter of Section 7 and part of the Southwest Quarter of Section 8, all in Township 8 North, Range 7 West of the Third Principal Meridian, Macoupin County, Illinois, being more particularly described as follows: Beginning at the Northwest corner of said Southwest Quarter; Thence South 88 degrees 31 minutes 50 seconds East along the North line of said Southwest Quarter, a distance of 2334.66 feet; Thence South 20 degrees 03 minutes 05 seconds West, a distance of 389.72 feet; Thence North 65 degrees 14 minutes 29 seconds West, a distance of 516.70 feet; Thence North 87 degrees 55 minutes 03 seconds West, a distance of 323.24 feet; Thence South 48 degrees 16 minutes 52 seconds West, a distance of 460.28 feet; Thence South 29 degrees 29 minutes 57 seconds West, a distance of 220.85 feet; Thence South 41 degrees 42 minutes 09 seconds West, a distance of 118.42 feet; Thence South 78 degrees 33 minutes 06 seconds West, a distance of 70.88 feet; Thence North 77 degrees 40 minutes 44 seconds West, a distance of 257.25 feet; Thence North 66 degrees 23 minutes 50 seconds West, a distance of 361.12 feet; Thence North 49 degrees 06 minutes 36 seconds West, a distance of 714.94 feet; Thence North 41 degrees 34 minutes 19 seconds West, a distance of 185.78 feet to the North line of said Southeast Quarter; Thence South 89 degrees 00 minutes 05 seconds East along said North line, a distance of 438.57 feet to the point of beginning.
